MOTION OF APPALACHIAN POWER COMPANY TO MODIFY THE PROCEDURAL SCHEDULE AND FOR EXPEDITED CONSIDERATION

Pursuant to Rules 110 and 230 of the Rules of Practice and Procedure of the State

Corporation Commission ("Commission"), 5 VAC 5-20-110 and 5 VAC 5-20-230, Appalachian

Power Company ("APCo" or the "Company"), by counsel, hereby respectfully moves the

Commission to modify the Order for Notice and Hearing dated April 11, 2025 (the "Procedural

Order") and reschedule the deadline for Publication of Notice from April 23, 2025 to April 24,

2025. Due to the nature of the deadline involved, the Company also requests expedited

consideration of this Motion. In support thereof, the Company states as follows:

1. On April 1, 2025, the Company filed a petition for approval of a minimum bill, tariffs, and agreements to implement a shared solar program ("Petition")¹ in the above-captioned proceeding.

2. On April 11, 2025, the Commission entered the Procedural Order² in this proceeding, which, among other things, established a procedural schedule. The procedural schedule set forth in the Procedural Order includes the following dates:

- 3. The Procedural Order directed the Company to publish notice in newspapers of general circulation in the Company's Virginia service territory by April 23, 2025. The Company promptly initiated the newspaper publication process; however, due to the tight turnaround time, the Company has been informed that at least three newspapers will be unable to publish the notice until April 24, 2025.
- 4. The Commission has discretion to grant a "continuance, postponement, or extension of time for the filing of a document or the taking of an action required or permitted by" the Commission's Rules of Practice and Procedure such as the date for Publication of Notice.³

 Accordingly, the Company respectfully requests the Commission reschedule the deadline for Publication of Notice from April 23, 2025 to April 24, 2025.

- 5. Because this Motion only requests a one-day extension, all interested parties will still have the opportunity to join and fully participate in the hearing scheduled for June 9, 2025.
 Granting this Motion will not prejudice any party.
- 6. Given the upcoming deadlines, the Company respectfully requests expedited consideration of this Motion.
- 7. Counsel for the Company conferred with counsel for all current participants (Staff, Appalachian Voices, and the Coalition for Community Solar Access ("CCSA")), and the Company is authorized to represent that Staff, Appalachian Voices, and CCSA do not oppose the Motion.

WHEREFORE, for good cause shown, the Company respectfully requests that the Commission, on an expedited basis, grant the Company's request to extend the deadline for Publication of Notice to April 24, 2025, and any other such relief as may be deemed appropriate by the Commission.
