PUBLIC UTILITY LAW JUDGE'S NOTICE OF PROCEDURAL DATES

On December 20, 2024, Jade Meadow III, LLC ("Applicant") filed an application ("Application") for a Certificate of Public Convenience and Necessity ("CPCN") for authority to construct a 300 megawatt ("MW") alternating current ("AC") capacity solar energy generating system utilizing fixed-tilt solar photovoltaic ("PV") modules with associated interconnection facilities in Garrett and Allegany Counties, Maryland (the "Project"). The proposed Project is to be constructed with a limit of disturbance of 1,852 acres of a total 5,933 acres made up of 32 parcels along Route 36/135 in proximity to Westernport and Barton, Maryland. A small segment (approximately 3500 feet) of an overhead collector line occupying approximately 20 acres is also proposed in Allegany County. The majority of the Project site was previously used for mining.²

Additionally, the Application requested a waiver of Public Utilities Article, Annotated

Code of Maryland § 7-208(c) requiring filing at least two years prior to the commencement

of construction.³

On December 20, 2024, the Public Service Commission of Maryland ("the

Commission") docketed the Application as Case No. 9769 and delegated the matter to the

Public Utility Law Judge Division.⁴

COMAR 20.79.01.10A requires that after an application to construct a new generating

station and within 45 days after the Commission has issued an order docketing and delegating

the matter, the Department of Natural Resources, Power Plant Research Program ("PPRP")

shall file a letter with the Commission stating whether the application meets the requirements

under COMAR 20.79.01.06 for a complete application. Therefore, PPRP is directed to file a

completeness determination on or before **Monday**, **February 3**, 2025. Additionally,

COMAR 20.79.01.05 sets forth several pre-application consultation requirements on an

applicant for a CPCN. Any party that contends the Applicant failed to comply with those

requirements shall file a letter detailing the alleged deficiency by Monday, February 3, 2025.

A pre-hearing conference will be scheduled at a later date.
