- Please refer to page 19 of the 1898 & Co. SPS System Resiliency Investment Study attached to SPS's application for approval of its transmission and distribution system resiliency plan (bates page 148), which describes the financial factors accounted for within the calculation of resiliency and risk Benefit-Cost Ratios (BCRs). Among these financial factors are "discounted cash flow methodology over the lifecycle of the infrastructure in mitigating events over the next 50 years 2.5% for escalation, 6.5% for discount rate (consistent with the values established in SPS's most recent base-rate proceeding."
 - a. Was any sensitivity analysis conducted on these assumptions? If so, how sensitive is the BCR analysis to these assumptions?
 - b. Would the calculated BCRs substantively change in response to minor changes to one or more of these parameters?
- Staff 1-2 Under 16 TAC 25.62(c)(2)(C)(iii), the resiliency plan must include an estimate or analysis of the expected effectiveness of each measure using the selected evaluation metric or criteria. Please refer to Attachment A of SPS's SRP Errata, which states "[t]he metrics SPS proposes to evaluate the effectiveness of the Wildfire Mitigation measure include calculating and reporting the number of units identified and completed in Tier 2 and 3 wildfire areas for DSP, and detailed inspections executed in Tier 2 and 3 wildfire areas." Please elaborate further on how these metrics are able to demonstrate the effectiveness of this measure.
- Staff 1-3 Please refer to Table 7-1 in the 1898 & Co. SPS System Resiliency Investment Study attached to SPS's application for approval of its transmission and distribution system resiliency plan (bates page 275), which outlines the percentage improvement in CMI for all projects with a BCR of at least 1, across all measures included in the SRP.
 - a. What is the corresponding percentage improvement in CMI for projects with a BCR < 1?
 - b. What is the corresponding percentage improvement in CMI for all projects (with any value of BCR) included in this evaluation?
