LEGAL NOTICE

The Public Utilities Commission of Ohio (Commission) has scheduled a local public hearing in Case No. 24-798-WW-AIR, *In the Matter of the Application of Christi Water System, Inc. for an Increase in Rates and Charges*. This local hearing is scheduled for the purpose of providing an opportunity to interested members of the public to testify in this proceeding. The local hearing will be held at the following time and location: April 28, 2025, at 6:00 p.m., at the Defiance City Hall, City Council Room, 631 Perry Street, Defiance, Ohio 43512.

By its application, Christi Water System, Inc. (Christi) seeks a rate and charge increase under a new, consolidated rate structure. According to a Commission staff report, under the rates and terms proposed by Christi, a customer using 800 cubic feet (c.f.) of water would see a bill increase of approximately 18.5 percent. The current rates include base rates established in Case No. 20-1428-WW-AIR and purchase water rate last updated in Case No. 24-232-WW-PWA, respectively. Pursuant to the application, Christi proposes to increase rates and to consolidate its purchased water rate with its base rates.
