ORDER

On April 14, 2021, AEUG Mason Solar, LLC (AEUG Mason) filed a notice of intent (NOI) to file an application for a Construction Certificate for an approximately 250-megawatt merchant electric solar generating facility to be located in Mason County, Kentucky. A renewed NOI was filed on November 24, 2021, and another on June 21, 2022. To date, an application has not been filed. On March 5, 2025, correspondence was filed into the record requesting that AEUG Mason file a status report within 30 days because the NOI that was filed for the case has expired. On April 16, 2025, AEUG Mason filed notice that it was withdrawing the NOI to file an application. AEUG Mason requested that the case be closed and removed from the Siting Board's docket.

Since AEUG Mason withdrew its NOI, the Siting Board finds the case should now be closed and removed from the docket.

IT IS THEREFORE ORDERED the case is closed and removed from the Siting Board's docket.
