**PUBLIC UTILITY LAW JUDGE'S NOTICE
OF INITIAL PUBLIC COMMENT HEARING**

On December 20, 2024, Jade Meadow III, LLC ("Applicant") filed an application ("Application") for a Certificate of Public Convenience and Necessity ("CPCN") for authority to construct a 300 megawatt ("MW") alternating current ("AC") capacity solar energy generating system utilizing fixed-tilt solar photovoltaic ("PV") modules with associated interconnection facilities in Garrett and Allegany Counties, Maryland (the "Project").¹ The proposed Project is to be constructed with a limit of disturbance of 1,852 acres of a total 5,933 acres made up of 32 parcels along Route 36/135 in proximity to Westernport and Barton, Maryland. A small segment (approximately 3500 feet) of an overhead collector line occupying approximately 20 acres is also proposed in Allegany County. The majority of the Project site was previously used for mining.²

Notice is hereby given that an initial public hearing will be held **on Tuesday, April 15, 2025, at 7:00 p.m., via virtual meeting**. The hearing will begin with a presentation by the Applicant, followed by brief statements by the Department of Natural Resources, Power Plant Research Program ("PPRP"); Maryland Office of People's Counsel ("OPC"); and the Technical

Commenters utilizing the Public Comment Dropbox are required to complete a one-time registration. All comments must include a reference to **Case No. 9769**. Only one copy is required.

The Applicant is hereby directed to:

Publish notice of the hearing, including the caption, case number, time, and date of the hearing, as a display advertisement in a newspaper of general circulation throughout Garrett and Allegany Counties, including in the

Post on at least two routinely used social media platforms, such as Facebook or X (f/k/a Twitter), and use any other means of communication at its disposal to further notify Garrett and Allegany County residents/businesses of the date and time of the hearing, and the link to the PULJ Division's YouTube Channel, and the methods and date by which written public comments may be submitted.

- File a certificate(s) of publication and all other methods of providing notice set forth herein with the Commission on or before the date of the hearing.
