On behalf of Oliver Wind IV, LLC, I am writing to provide additional information regarding Oliver Wind IV's Tree and Shrub Mitigation Plan filed on April 28<sup>th</sup>, 2025 in the above-referenced matters. Since the April 28<sup>th</sup> filing, Oliver Wind IV has received three additional landowner waivers which are enclosed for filing.

For all of the remaining landowners designated as an "opt-out" in the Plan, Oliver Wind IV has received a verbal waiver specifying the landowners' preference to waive tree and shrub replanting from occurring on their property. Additional information regarding the remaining landowners is provided below. To the extent Oliver Wind IV receives executed written waivers from the below identified landowners, copies will subsequently be provided to the Commission.

- Marvin Beckman: Verbal opt out received on 03/27/2025.
- Dwight Henke: Verbal opt out received on 04/02/2025.
- Ryan and Darby Henke: Verbal confirmation received from landowner on 04/28/2025 that an executed waiver would be returned to Oliver Wind IV that same week.
- Dave Henke: Various conversations with landowner between 03/28/2025 and 04/05/2025 indicating landowner's preference to opt out of replantings occurring directly on Mr. Henke's property. Mr. Henke communicated a preference for replanting to alternatively
