Based on scheduling concerns expressed during the June 24 hearing in this proceeding, Public Service Company of New Hampshire d/b/a Eversource Energy ("Eversource") hereby proposes a modification to the schedule for the next competitive solicitation, regulatory filing, hearing date, and order issuance date for the default Energy Service rate adjustment to become effective on February 1, 2026. The proposed modified schedule is as follows:
