

Now before the Commission, through undersigned counsel, comes Southwestern Electric Power Company (SWEPCO), and files this Motion for Leave to file out of time Request to Participate as an Interested Party and for inclusion on the service list, and respectfully represents as follows:

1.

SWEPCO operates an electric public utility within the State of Louisiana, with its principal place of business located at 428 Travis Street, Shreveport, Louisiana 71101.

2.

SWEPCO is a public utility owning and operating generation, transmission and distribution facilities in Louisiana, Arkansas, and Texas, and is subject to the jurisdiction of the Louisiana Public Service Commission.

3.

The Commission published notice of this docket in Official Bulletin #1336, issued on November 8, 2024. Interventions or appearances were due on or before November 18, 2024, ten days from the date of publication of notice.

4.

This proceeding was initiated by Entergy Louisiana, LLC seeking, among other things, Commission approval of the generation and transmission resources needed to serve a substantial new load proposed for a customer seeking to locate a large facility in Richland Parish, Louisiana.

As an electric public utility providing retail electric service, and owning and operating generation, transmission and distribution facilities in Louisiana, SWEPCO has an interest in the outcome of this proceeding. SWEPCO therefore wishes to participate in the above-captioned docket as an Interested Party for monitoring purposes.

Accordingly, SWEPCO desires to participate in this proceeding as an Interested Party and to be placed on the Official Service List and provided with copies of all notices, correspondence, communications, pleadings, and other filings in this docket, and prior notice of any and all hearings and proceedings which may be set in this matter. SWEPCO's participation at this time will not adversely affect any party.

In light of these circumstances, SWEPCO moves for leave to file its Request to Participate as an Interested Party.
