NEW ENERGY ECONOMY'S UNOPPOSED MOTION TO INTERVENE

COMES NOW New Energy Economy (NEE), by and through its attorneys Mariel Nanasi, pursuant to 1.2.2.10.C & D, 1.2.2.23(A) and 1.2.2.25(H)(3) NMAC moves the New Mexico Public Regulation Commission (PRC) for leave to intervene and for expansion of the service list, and requests each party hereto to serve all discovery requests and responses on undersigned counsel in this proceeding. In support of this Motion, New Energy Economy states:

 The subject matter of this proceeding and its outcome will have an impact on NEE, its constituents, and all people of New Mexico. This docket includes numerous issues that are of importance to NEE, including whether New Mexico Gas Company ("NMGC"), Saturn Utilities Holdco, LLC ("Saturn Holdco"), and affiliated applicants, should be granted approval of the acquisition by Saturn Holdco of NMGC and the divestiture by Emera, Emera U.S. Holdings, Inc., and TECO Holdings, Inc. of their current ownership of NMGC (the "Transaction").

- 2. Saturn Holdco is owned by a set of infrastructure investment funds who are among the applicants. In short, Saturn Holdco will replace Emera as owner of NMGC.
- No other party in this proceeding can adequately represent the interests of New Energy Economy members.
- 4. New Energy Economy has actively participated in many cases before the PRC involving New Mexico utilities, including NMGC's last rate cases, Case No. 21-00267-UT and 23-000255-UT, its Certificate of Convenience and Necessity ("CCN") application for approval of a Liquified Natural Gas Plant, Case No. 22-00309-UT.
- 5. Pursuant to NM PRC rules New Energy Economy respectfully requests that NEE be served via U.S. mail with all testimony (including supplemental, rebuttal testimony, etc.) and by email with copies of all filings in this matter as well as all discovery requests, responses and objections made by any party in this proceeding.
