- {¶ 1} Christi Water System, Inc. (Christi or Applicant) is a waterworks company as defined by R.C. 4905.03(G) and a public utility as defined by R.C. 4905.02, and, as such, is subject to the jurisdiction of this Commission pursuant to R.C. 4905.04, 4905.05, and 4905.06.
- $\{\P 2\}$ An application for an increase in rates is governed by, and must meet, the requirements of R.C. 4909.17, 4909.18, 4909.19, and 4909.42.
- {¶ 3} On August 8, 2024, and amended on August 29, 2024, Applicant filed an abbreviated application to increase its rates for water service, pursuant to R.C. 4909.18.
- {¶ 4} On September 3, 2024, the Ohio Consumers' Counsel (OCC) filed a motion to intervene in this case. No memoranda contra were filed. By Entry issued on October 15, 2024, the Commission granted OCC's motion to intervene in this case.
- {¶ 5} On September 5, 2024, Staff filed a review and recommendation in which Staff concluded that Applicant's abbreviated application substantively conforms to the Standard Filing Requirements for Rate Increases (SFR) as described in Ohio Adm.Code 4901-7-01.
- $\{\P 6\}$ On October 15, 2024, the Commission determined (1) that the application was accepted as of the amended filing date of August 29, 2024, (2) that the application conforms to the SFR, (3) that the test period for the application is January 1, 2023, to December 31, 2023, (4) that the date certain for the application is December 31, 2023, and (5)

that Applicant's requested waiver of R.C. 4909.18(A) through (E) is reasonable and should be granted.

- {¶ 7} Pursuant to R.C. 4909.19, Staff conducted an investigation of the facts, exhibits, and matters relating to Christi's application and filed its Staff Report on March 21, 2025.
- {¶ 8} Pursuant to R.C. 4909.19 and Ohio Adm.Code 4901-1-28(B), all objections to the Staff Report must be filed within 30 days after the filing of such report. Therefore, all objections must be filed by April 21, 2025. All objections must be specific. Any objection that is not specific enough to convey what is actually being placed at issue will be struck pursuant to the above-cited rule.
- $\{\P 9\}$ Motions to intervene in this case should be filed by April 21, 2025, in accordance with Ohio Adm.Code 4901-1-11.
- {¶ 10} Motions to strike objections to the Staff Report should be filed by April 28, 2025; memoranda contra motions to intervene, as well as memoranda contra motions to strike objections to the Staff Report, should be filed by May 5, 2025. Unless an objection is struck or withdrawn, each objection must be discussed in the initial post-hearing brief of the objecting party. If an objection is not discussed in the initial brief, the objection will, without further action, be deemed withdrawn.
 - **{¶ 11}** Direct expert testimony in this case should be filed by May 14, 2025.
- {¶ 12} R.C. 4903.083 requires that the Commission hold at least one public hearing session within Christi's service territory and that at least one session of the local public hearing be scheduled after 5:00 p.m. Accordingly, the local public hearing has been scheduled at the following time and location:
 - (a) April 28, 2025, at 6:00 p.m., at the Defiance City Hall, City Council Room, 631 Perry Street, Defiance, Ohio 43512.

{¶ 13} Christi should publish legal notice of the local hearing in a newspaper of general circulation in all of the affected service territory once a week for two consecutive weeks prior to the scheduled date of the local hearing. The hearing notice should not appear in the legal notices section of the newspaper. The notice should read as follows:

The Public Utilities Commission of Ohio (Commission) has scheduled a local public hearing in Case No. 24-798-WW-AIR, *In the Matter of the Application of Christi Water System, Inc. for an Increase in Rates and Charges*. This local hearing is scheduled for the purpose of providing an opportunity to interested members of the public to testify in this proceeding. The local hearing will be held at the following time and location: April 28, 2025, at 6:00 p.m., at the Defiance City Hall, City Council Room, 631 Perry Street, Defiance, Ohio 43512.

By its application, Christi Water System, Inc. (Christi) seeks a rate and charge increase under a new, consolidated rate structure. According to a Commission staff report, under the rates and terms proposed by Christi, a customer using 400 cubic feet (c.f.) of water would see a bill increase of approximately 18.5 percent. The current rates include base rates established in Case No. 20-1428-WW-AIR and purchase water rate last updated in Case No. 24-232-WW-PWA, respectively. Pursuant to the application, Christi proposes to increase rates and to consolidate its purchased water rate with its base rates.
