**Response:** There was a typographical error in the narrative portion of the Application, which incorrectly stated that three additional wetlands were identified during field surveys. The correct number of additional wetlands identified is two, as accurately documented in the delineation report. The Applicant confirms that both of these additional wetlands will be avoided.
