- ☐ **1. Menu** — Confirm each product under Illinois cottage food rules (county cannot expand a state ban).
- ☐ **2. Pickup & zoning** — Home occupation and porch pickup cells above; HOA/lease may still block customer traffic.
- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

LABEL FIELDS TO INCLUDE

- ☐ Product name · producer name · address (or allowed alternative)
- ☐ Ingredients by weight · major allergens · net weight/quantity
- ☐ Illinois home-kitchen disclaimer (see live label one-pager)

RESEARCH NOTES

No county-specific cottage food ordinance found that overrides state law. Illinois 410 ILCS 625/4 preempts local rules inconsistent with state law (2022 PA 102-0633 and 2025 PA 103-0903 amendments). Local zoning may regulate signage, customer traffic, and parking at home sales locations but cannot prohibit or restrict allowed foods/venues inconsistently with state law. Registration required with local county health department (up to \$50/year); CFPM-level food safety certificate required. No sales cap. Defaulting to state baseline.

State context — Illinois cottage food law

Woodford County's rules sit on top of Illinois's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

No — Illinois prohibits sales to restaurants, retail stores, and wholesale; direct in-state sales are allowed anywhere including home, online, farmers markets, events, and roadside stands; non-perishable items may be shipped within Illinois only.
