- ☐ **1. Menu** — Confirm each product under Kansas cottage food rules (county cannot expand a state ban).
- ☐ **2. Pickup & zoning** — Home occupation and porch pickup cells above; HOA/lease may still block customer traffic.
- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

LABEL FIELDS TO INCLUDE

- ☐ Product name · producer name · address (or allowed alternative)
- ☐ Ingredients by weight · major allergens · net weight/quantity
- ☐ Kansas home-kitchen disclaimer (see live label one-pager)

HOME KITCHEN ALLOWED?

Yes (Kansas exempts non-TCS (shelf-stable) homemade foods sold direct-to-consumer from food establishment licensing requirements (K.S.A. §65-689(d)(4)). No registration, inspection, or food handler certificate required at state level. Local zoning home occupation rules may apply — contact Chautauqua County zoning office.)

Home kitchen rules

HOME KITCHEN ALLOWED

Yes — Kansas exempts non-TCS (shelf-stable) homemade foods sold direct-to-consumer from food establishment licensing requirements (K.S.A. §65-689(d)(4)). No registration, inspection, or food handler certificate required at state level. Local zoning home occupation rules may apply — contact Chautauqua County zoning office.

SEPARATE DEDICATED KITCHEN

PET RESTRICTIONS

No specific pet restriction in state cottage food law; good sanitary practices required.

WATER SUPPLY

No specific water testing requirement under Kansas cottage food exemption.

HANDWASHING

Good sanitary practices required per Kan. Admin. Regs. §4-28-33.

FOOD STORAGE

Non-TCS (shelf-stable) foods only; no refrigeration-required products.

Inspection & permitting

INSPECTION REQUIRED

Upon-complaint — Kansas Department of Agriculture may investigate complaints; no routine home kitchen inspection for exempt cottage food operations.

HOME OCCUPATION PERMIT

Varies — No state-level food permit required for non-TCS cottage foods. Local zoning ordinances for home occupations may require a permit. Contact Chautauqua County zoning or planning office (Sedan) to verify requirements.

Relevant county code

No specific Chautauqua County cottage food ordinance identified. State exemption (K.S.A. §65-689(d)(4)) applies statewide.

RESEARCH NOTES

Kansas cottage food exemption (K.S.A. §65-689(d)(4)) applies statewide. Chautauqua County is a small south Kansas county near Oklahoma border; no county-specific cottage food ordinance found.

State context — Kansas cottage food law

Chautauqua County's rules sit on top of Kansas's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

No — Indirect sales to restaurants, retail stores, or wholesale are not allowed under the exemption; producers needing wholesale or retail channels must obtain a KDA food processing license.
