Kansas Great-tier state. Mitchell County is a small north-central Kansas county (pop. ~5,987). No county-specific cottage food or home occupation ordinance found. State cottage food law (K.S.A. §65-657) is primary framework.

State context — Kansas cottage food law

Mitchell County’s rules sit on top of Kansas’s state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.
