Kansas Great-tier state. Morris County is a small central Kansas county (pop. ~5,620). Council Grove is a historic Katy Trail city. No county-specific cottage food or home occupation ordinance found. State cottage food law (K.S.A. §65-657) is primary framework.

State context — Kansas cottage food law

Morris County’s rules sit on top of Kansas’s state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

STATUTE K.S.A. §65-657	ANNUAL SALES CAP —
REGISTRATION REQUIRED No	FOOD HANDLER CERT No
KITCHEN INSPECTION Upon-complaint	DIRECT SALES ONLY Yes
INDIRECT SALES No — Indirect sales to restaurants, retail stores, or wholesale are not allowed under the exemption; producers needing wholesale or retail channels must obtain a KDA food processing license.
