Kansas Great-tier state. Seward County is a mid-size southwestern Kansas county (pop. ~21,942) with a large Hispanic population. No county-specific cottage food or home occupation ordinance found. State cottage food law (K.S.A. §65-657) is primary framework.

State context — Kansas cottage food law

Seward County’s rules sit on top of Kansas’s state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.
