No county-specific cottage food or home occupation ordinances found for Warren County. County seat Vicksburg is historically significant city on the Mississippi River. Governance follows state law. State context — Mississippi cottage food law

Warren County's rules sit on top of Mississippi's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

KITCHEN INSPECTION Upon-complaint	DIRECT SALES ONLY Yes
INDIRECT SALES No — Mississippi prohibits Internet sales, mail order, wholesale, and retail establishment sales. Cottage food products may only be sold through in-person direct-to-consumer channels including events, farmers markets, home sales, and roadside stands. Advertising on the Internet including social media is permitted even though sales through those channels are not.
