PET RESTRICTIONS	Not specified in state cottage food law.
WATER SUPPLY	Not specified in state cottage food law.
HANDWASHING	Standard sanitation practices; not specifically required by statute.
FOOD STORAGE	Products must be non-potentially hazardous and not require refrigeration.

INSPECTION REQUIRED	Upon-complaint — No routine inspection. MSDH may inspect upon complaint or suspected foodborne illness.
HOME OCCUPATION PERMIT	Conditional — No specific Winston County cottage food or home occupation rules found. City of Louisville may have business license requirements. Recommend verifying with Winston County planning/zoning department.

State context — Mississippi cottage food law

Winston County's rules sit on top of Mississippi's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

INDIRECT SALES

No — Mississippi prohibits Internet sales, mail order, wholesale, and retail establishment sales. Cottage food products may only be sold through in-person direct-to-consumer channels including events, farmers markets, home sales, and roadside stands. Advertising on the Internet including social media is permitted even though sales through those channels are not.
