RESEARCH NOTES

Nebraska Good-tier state. State law (§81-2,280 as amended by LB262, July 2024) is the primary framework. Colfax County (pop. ~10,515) is a small eastern NE county. No county-specific cottage food ordinance found. State registration with NDA required. Direct sales only; no wholesale.

State context — Nebraska cottage food law

Colfax County’s rules sit on top of Nebraska’s state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

INDIRECT SALES	
No — Sales must be direct-to-consumer. Wholesale to restaurants, grocery stores, or distributors is not permitted under the cottage food framework. Non-TCS foods may be mailed; TCS foods must be delivered in person by the producer within 2 hours.
