New Mexico §25-12-5 expressly preempts county and municipal regulation of homemade food production and sales. Luna County is a rural agricultural county; no county-specific cottage food ordinances found. State baseline applied at high confidence.

State context — New Mexico cottage food law

Luna County's rules sit on top of New Mexico's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

STATUTE NMSA §25-12-3 (Homemade Food Act)	ANNUAL SALES CAP —
REGISTRATION REQUIRED No	FOOD HANDLER CERT Yes
KITCHEN INSPECTION No	DIRECT SALES ONLY Yes
INDIRECT SALES No — Sales must be direct to consumers within New Mexico. Products may not be sold to restaurants, wholesalers, distributors, or outside New Mexico. Internet, mail, and phone sales directly to consumers are permitted. The NMED Food Safety Program does not have jurisdiction in Bernalillo County and Albuquerque (which have their own programs); those areas may operate mandatory or voluntary permit systems.
