- ☐ **1. Menu** — Confirm each product under North Dakota cottage food rules (county cannot expand a state ban).
- ☐ **2. Pickup & zoning** — Home occupation and porch pickup cells above; HOA/lease may still block customer traffic.
- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

LABEL FIELDS TO INCLUDE

- ☐ Product name · producer name · address (or allowed alternative)
- ☐ Ingredients by weight · major allergens · net weight/quantity
- ☐ North Dakota home-kitchen disclaimer (see live label one-pager)

RESEARCH NOTES

Ramsey County is a rural North Dakota county. No county-specific cottage food or home occupation zoning ordinance was identified for the unincorporated county area. North Dakota's cottage food law (N.D. Cent. Code ch. 23-09.5) is highly permissive with no sales cap, no registration, no inspection, and a broad product definition. County-level zoning is minimal or absent in most ND counties; state law governs.

State context — North Dakota cottage food law

Ramsey County's rules sit on top of North Dakota's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

INDIRECT SALES

No — Transactions must be directly between the cottage food operator and the 'informed end consumer' and solely for home consumption. Products may not be sold or used in any food establishment, food processing plant, or food store. No wholesale channel is permitted.
