**RESEARCH NOTES**

Williams County is a rural North Dakota county. Williams County has Zoning Ordinance and Subdivision Regulations on file. No specific cottage food restrictions found beyond state law. North Dakota's cottage food law (N.D. Cent. Code ch. 23-09.5) is highly permissive with no sales cap, no registration, no inspection, and a broad product definition. County-level zoning is minimal or absent in most ND counties; state law governs.

## State context — North Dakota cottage food law

Williams County's rules sit on top of North Dakota's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.
