## QUICK VIEW FOR BAKERS IN THIS COUNTY

**HOME KITCHEN ALLOWED?**

Yes (Tennessee Food Freedom Act (Tenn. Code §53-1-125, effective July 1, 2022) broadly allows any non-TCS homemade food from a private residence. No license, permit, inspection, or registration required. No sales cap. No labeling requirements beyond a disclosure statement.)

**SEPARATE KITCHEN REQUIRED?**

No

**PETS ALLOWED?**

No specific pet restriction in state law; standard food safety hygiene practices apply.

**HOME OCCUPATION PERMIT?**

Varies (Bledsoe County zoning regulations may require a home occupation permit for commercial activities at a residence. Operators should check with Bledsoe County offices in Pikeville.)

**ON-SITE / PORCH PICKUP?**

Yes

**INSPECTION REQUIRED?**

No (DOH may investigate only in connection with a foodborne illness investigation; no routine or complaint-only inspection authority for cottage food.)

## Home kitchen rules

<b>HOME KITCHEN ALLOWED</b>	Yes — Tennessee Food Freedom Act (Tenn. Code §53-1-125, effective July 1, 2022) broadly allows any non-TCS homemade food from a private residence. No license, permit, inspection, or registration required. No sales cap. No labeling requirements beyond a disclosure statement.
<b>SEPARATE DEDICATED KITCHEN</b>	No
<b>PET RESTRICTIONS</b>	No specific pet restriction in state law; standard food safety hygiene practices apply.
<b>WATER SUPPLY</b>	No specific state cottage food water supply requirement.
<b>HANDWASHING</b>	No specific state cottage food handwashing mandate; standard hygiene practices recommended.
<b>FOOD STORAGE</b>	No specific state cottage food storage requirement; non-TCS foods must be stored appropriately.

## Inspection & permitting

<b>INSPECTION REQUIRED</b>	No — DOH may investigate only in connection with a foodborne illness investigation; no routine or complaint-only inspection authority for cottage food.
<b>HOME OCCUPATION PERMIT</b>	Varies — Bledsoe County zoning regulations may require a home occupation permit for commercial activities at a residence. Operators should check with Bledsoe County offices in Pikeville.
<b>LOCAL BUSINESS LICENSE</b>	Varies

### Customer-facing rules

ON-SITE CUSTOMER PICKUP	Yes
ON-SITE SIGNAGE	Conditional
DELIVERY / PICKUP RULES	Broad — direct and indirect sales permitted. Online, in-person, delivery, farmers markets, retail stores all allowed under Tennessee Food Freedom Act.
MAX EMPLOYEES IN HOME	Not specified in state law.

### Relevant county code

Bledsoe County Zoning Code (home occupation provisions); no specific cottage food county code identified.

#### RESEARCH NOTES

No county-specific cottage food ordinance found for Bledsoe County, TN. Applied Tennessee Food Freedom Act state baseline (Tenn. Code §53-1-125, eff. July 1, 2022). Bledsoe County is a rural county on the Cumberland Plateau (seat: Pikeville). County zoning for home occupation should be verified locally.

## State context — Tennessee cottage food law

Bledsoe County's rules sit on top of Tennessee's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

### INDIRECT SALES

Yes — The Tennessee Food Freedom Act (Public Chapter 862, effective July 1, 2022) broadly exempts production and sale of non-TCS homemade food items from all licensing, permitting, inspecting, packaging, and labeling laws. Sales may be direct to consumer in person or remotely. Local government ordinances restricting homemade food sales are preempted. Note: Prior to the 2022 Food Freedom Act, the older domestic kitchen regulations (TDA Chapter 0080-4-11) required a permit, inspection, and food safety certification, and limited sales to 100 units/week; the Food Freedom Act supersedes these requirements for qualifying non-TCS homemade foods.
