No specific pet restriction in state law; standard food safety hygiene practices apply.

### HOME OCCUPATION PERMIT?

Varies (Campbell County zoning regulations may require a home occupation permit for commercial activities at a residence. Operators should check with Campbell County offices in Jacksboro.)

### ON-SITE / PORCH PICKUP?

### INSPECTION REQUIRED?

No (DOH may investigate only in connection with a foodborne illness investigation; no routine or complaint-only inspection authority for cottage food.)

#### RESEARCH NOTES

No county-specific cottage food ordinance found for Campbell County, TN. Applied Tennessee Food Freedom Act state baseline (Tenn. Code §53-1-125, eff. July 1, 2022). Campbell County is in northeastern TN (seat: Jacksboro). County zoning for home occupation should be verified locally.

## State context — Tennessee cottage food law

Campbell County’s rules sit on top of Tennessee’s state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

### INDIRECT SALES

Yes — The Tennessee Food Freedom Act (Public Chapter 862, effective July 1, 2022) broadly exempts production and sale of non-TCS homemade food items from all licensing, permitting, inspecting, packaging, and labeling laws. Sales may be direct to consumer in person or remotely. Local government ordinances restricting homemade food sales are preempted. Note: Prior to the 2022 Food Freedom Act, the older domestic kitchen regulations (TDA Chapter 0080-4-11) required a permit, inspection, and food safety certification, and limited sales to 100 units/week; the Food Freedom Act supersedes these requirements for qualifying non-TCS homemade foods.
