No specific pet restriction in state law; standard food safety hygiene practices apply.

### HOME OCCUPATION PERMIT?

Varies (Carroll County zoning regulations may require a home occupation permit for commercial activities at a residence. Operators should check with Carroll County offices in Huntingdon.)

### INSPECTION REQUIRED?

No (DOH may investigate only in connection with a foodborne illness investigation; no routine or complaint-only inspection authority for cottage food.)

## Inspection & permitting

### Relevant county code

Carroll County Zoning Code (home occupation provisions); no specific cottage food county code identified.

#### RESEARCH NOTES

No county-specific cottage food ordinance found for Carroll County, TN. Applied Tennessee Food Freedom Act state baseline (Tenn. Code §53-1-125, eff. July 1, 2022). Carroll County is in western TN (seat: Huntingdon). County zoning for home occupation should be verified locally.

## State context — Tennessee cottage food law

Carroll County’s rules sit on top of Tennessee’s state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

**INDIRECT SALES**  
 Yes — The Tennessee Food Freedom Act (Public Chapter 862, effective July 1, 2022) broadly exempts production and sale of non-TCS homemade food items from all licensing, permitting, inspecting, packaging, and labeling laws. Sales may be direct to consumer in person or remotely. Local government ordinances restricting homemade food sales are preempted. Note: Prior to the 2022 Food Freedom Act, the older domestic kitchen regulations (TDA Chapter 0080-4-11) required a permit, inspection, and food safety certification, and limited sales to 100 units/week; the Food Freedom Act supersedes these requirements for qualifying non-TCS homemade foods.
