Delaware's cottage food rules are set by 16 Del. Admin. Code 4458A. The summary below is drawn from Crosodo's verified statute research and official agency guidance. Always confirm current requirements on the state agency website before you sell.

What foods are allowed?

- Delaware allows certain non-potentially hazardous foods including specific baked goods (breads, cakes, cookies, pies, pastries), candy, jams, jellies, and other fruit preserves. Other non-PHF foods may be allowed after confirmation from the health department.

What foods are prohibited?

- Prohibited items include most perishable foods, low-acid and acidified canned foods, ketchup, mustards, nut butters, oils, pickles, salsas, sauces, dried fruits and vegetables, herbs, mixes, pasta noodles, spices, tea leaves, fermented foods, juices, and meat jerkies.
- TCS (time/temperature control for safety) foods are not permitted.

Can I sell to retailers or restaurants (indirect sales)?

- Delaware prohibits sales at restaurants, retail stores, and online; only direct in-person sales at home, farmers markets, and events are permitted.

Labeling

What labeling is required?

- Labels must include the town or city (format: 'City, Delaware'), either an email address or phone number, product name, ingredients in descending order of weight, and net weight/volume. Home address on label was removed as a requirement in December 2023.

Statute excerpt

16 Del. Admin. Code 4458A

What does the Delaware cottage food statute say?

- 1.1 Preamble. These regulations shall be known as the State of Delaware Cottage Food Regulations (Cottage Food Regs). 1.2 Purpose. Delaware Department of Health and Social Services adopts these regulations pursuant to the authority vested by 16 Del.C. §122.
- These regulations establish registration procedures and standards of practice for conducting food processing operations in home-style kitchens that safeguard public health and provide to consumers food that is safe, unadulterated, and honestly presented. 1.4 Exemptions 1.4.1 Establishments registered as food establishments in Delaware shall be exempt from the Cottage Food Regulations. 1.4.2 Establishments registered under these regulations shall be exempt from the Delaware Food Code.
- 1.4.3 Products offered at 'bake sales' or private events as described in the definition of food establishment in the Delaware Food Code shall be exempt from these regulations. 3.1.3.1 CFE are only permitted to engage in direct sales with consumers in the State of Delaware.

Executive summary

This report covers the Delaware cottage food framework — the state statute, the regulatory body administering it, what producers can and cannot sell, and county-level rules layered on top of state law for the 3 Delaware counties included in this dataset.

RESEARCH NOTES

The primary enabling statute is 16 Del.C. §122 but the operative rules are in 16 Del. Admin. Code 4458A (Cottage Food Regulations) first effective September 2016 and last amended December 2023. The December 2023 amendment (27 DE Reg. 432) removed the previously very low \$25,000 annual sales cap and removed the home address requirement from labels. Delaware also has a separate On-Farm Home Processing program under 3 Del. Admin. Code 101 for farmers. Despite an IJ grade of F, Delaware does have a functioning program — the F likely reflects the complexity of registration (pre-operational inspection, 8-hour food safety training costing ~\$175, plan review, \$30 annual fee). IJ and the program’s ‘Good’ tier in Crosodo data reflect this nuance. The state dept cottage URL may be outdated (404 as of verification date); the National Agricultural Law Center PDF (current through December 2024) was used as the primary statute source.

Allowed foods

Delaware allows certain non-potentially hazardous foods including specific baked goods (breads, cakes, cookies, pies, pastries), candy, jams, jellies, and other fruit preserves. Other non-PHF foods may be allowed after confirmation from the health department.

Prohibited foods

Prohibited items include most perishable foods, low-acid and acidified canned foods, ketchup, mustards, nut butters, oils, pickles, salsas, sauces, dried fruits and vegetables, herbs, mixes, pasta noodles, spices, tea leaves, fermented foods, juices, and meat jerkies. TCS (time/temperature control for safety) foods are not permitted.

Labeling requirements

Labels must include the town or city (format: 'City, Delaware'), either an email address or phone number, product name, ingredients in descending order of weight, and net weight/volume. Home address on label was removed as a requirement in December 2023.

Statutory text – verbatim excerpt

STATUTE EXCERPT – VERBATIM

1.1 Preamble. These regulations shall be known as the State of Delaware Cottage Food Regulations (Cottage Food Regs). 1.2 Purpose. Delaware Department of Health and Social Services adopts these regulations pursuant to the authority vested by 16 Del.C. §122. These regulations establish registration procedures and standards of practice for conducting food processing operations in home-style kitchens that safeguard public health and provide to consumers food that is safe, unadulterated, and honestly presented. 1.4 Exemptions 1.4.1 Establishments registered as food establishments in Delaware shall be exempt from the Cottage Food Regulations. 1.4.2 Establishments registered under these regulations shall be exempt from the Delaware Food Code. 1.4.3 Products offered at 'bake sales' or private events as described in the definition of food establishment in the Delaware Food Code shall be exempt from these regulations. 3.1.3.1 CFE are only permitted to engage in direct sales with consumers in the State of Delaware.

The state statute above sets the floor. Each county may add a home-occupation permit, business license, or zoning rule on top of state law. The 3 Delaware counties below are listed alphabetically (Crosodo Index* shown for reference – see methodology at end of report). RESEARCH NOTES

Delaware has one of the most restrictive cottage food programs nationally despite removal of sales cap in December 2023. Pre-operational inspection, 8-hour food safety training, \$30 annual fee, and limited approved food list all remain requirements. Kent County requires local zoning permit and business license per CityRuleLookup. County seat 'Dover' was blank in input — confirmed as Dover. DPH cottage food program page accessible at dhss.delaware.gov. Program not available in Philadelphia County (PA note, not DE).

Delaware is a Good-tier state. 16 Del. Admin. Code 4458A last amended December 2023 (removed \$25,000 sales cap, removed home address from label requirement). Narrow approved foods list (baked goods, candy, jams/jellies, fruit preserves). Pre-operational inspection required. 8-hour food safety training at ~\$175. \$30 annual fee. Direct sales only within Delaware. Home address no longer required on labels (registration number used instead). New Castle County-specific zoning/home occupation permit requirements not confirmed from direct source. Confidence medium.

RESEARCH NOTES

Sussex County DE follows Delaware state baseline (16 Del. Admin. Code 4458A). Delaware has one of the nation’s more restrictive programs — very limited food list, pre-operational inspection, 8-hour training requirement. December 2023 amendment removed sales cap and home address labeling requirement. No Sussex County-specific cottage food ordinance found. Confidence medium — state law confirmed but no specific Sussex County .gov cottage food source retrieved.

Score components (higher = better): home kitchen allowed (30/15/5), no dedicated kitchen required (25), pets allowed (15), no home occupation permit (15), on-site pickup allowed (10), no inspection (10), no local business license (5), high data confidence (5), plus state tier bonus (Freedom +20, Great +15, Good +10, Okay +5). Data drawn from county zoning codes, health department rules, and state cottage food statutes (primarily the county_cottage_food_zoning research set and state statutes CSV, last verified ~2026). Ranks are global across ~3,000 counties. Counties with sparse or missing data receive lower/default scores. This is a research and prioritization tool only — always verify current rules directly with your state department of agriculture/health and your county planning & health offices. The original U.S. Census population rank is retained in source data for reference but is no longer used for primary display or sorting in Crosodo materials.
