Maine's cottage food rules are set by 7 M.R.S.A. §282 (Food Sovereignty Act). The summary below is drawn from Crosodo's verified statute research and official agency guidance. Always confirm current requirements on the state agency website before you sell.

Program basics

What law governs cottage food in Maine?

- Maine Revised Statutes Title 7, Chapter 8-F — Direct Producer-to-Consumer Transactions (Food Sovereignty Act), Sections 282–285; originally enacted PL 2017, c. 314, last amended PL 2025, c. 309

Allowed products and sales channels

What foods are allowed?

- Under the Food Sovereignty Act, in municipalities with local food sovereignty ordinances, almost any food produced and sold in a direct producer-to-consumer transaction is allowed, including vegetables, fruits, eggs, dairy, meat, poultry, fish, seafood, cider, juice, acidified foods, canned fruits/vegetables, honey, nuts, maple products, baked goods, sandwiches, and other meals.
- Under the statewide home food processor license (separate from the Food Sovereignty Act), most shelf-stable non-TCS foods are allowed after kitchen inspection.

What foods are prohibited?

- Under the statewide home food processor license pathway, perishable baked goods are prohibited and low-acid pressure-canned foods made at home may not be sold. Acidified foods (salsas, pickles, certain dressings, chocolate sauces) require prior approval from the University of Maine's School of Food and Agriculture.
- The Food Sovereignty Act's municipal ordinance pathway has fewer prohibitions but is limited to participating municipalities.

Can I sell to retailers or restaurants (indirect sales)?

- Under the statewide Home Food Processor License, producers may sell at any venue including restaurants, retail stores, farmers markets, and online, with no sales limit; indirect wholesale and retail channels are allowed once licensed and kitchen-inspected.

Labeling

What labeling is required?

- Under the statewide license, label requirements apply for packaged products sold away from the home; however, no label is required for products sold directly from the producer's home. Labels for retail/market sales must include standard food labeling information.
- The Food Sovereignty Act municipal ordinance pathway may have different local requirements.

7 M.R.S.A. §282 (Food Sovereignty Act)

What does the Maine cottage food statute say?

- §282. Definitions As used in this chapter, unless the context otherwise indicates, the following terms have the following meanings. [PL 2017, c. 314, §1 (NEW).] 1. Direct producer-to-consumer transaction.
- "Direct producer-to-consumer transaction" means an exchange of food or food products directly between a food producer and a consumer by barter, trade or purchase on the property or premises owned, leased or rented by the food producer; at roadside stands, fundraisers, farmers' markets and community social events; or through buying clubs, deliveries or community-supported agriculture programs, herd-share agreements and other private arrangements. [PL 2023, c. 420, §1 (AMD).] 2.
- Food or food products.
- "Food or food products" means food or food products that are grown, produced, processed or prepared for human consumption, including, but not limited to, vegetables, fruit, eggs, grain or grain products, herbs, seasonings or spices, milk or milk products, meat or meat products, poultry or poultry products, fish or fish products, seafood or seafood products, cider or juice, acidified foods, canned fruits or vegetables, honey, nuts, maple products or condiments or any combination of those items, such as baked goods, sandwiches or other meals, and that are provided in a direct producer-to-consumer transaction.
- [PL 2025, c. 309, §5 (AMD).] 2-B. Food sovereignty. "Food sovereignty" means the right of persons to healthy and culturally appropriate food produced through ecologically sound and sustainable methods and the right of persons to define their own food and agriculture systems. §284.
- Authority Notwithstanding any provision of law regulating food in this Title or Title 22 to the contrary, except as contained in section 285, a municipality or plantation may adopt ordinances regarding traditional foodways and direct producer-to-consumer transactions, and the State shall recognize such ordinances by not enforcing those laws or implementing rules with respect to those traditional foodways or direct producer-to-consumer transactions that are governed by the ordinance.

Executive summary

This report covers the Maine cottage food framework — the state statute, the regulatory body administering it, what producers can and cannot sell, and county-level rules layered on top of state law for the 16 Maine counties included in this dataset.

RESEARCH NOTES

Maine’s food sovereignty framework has two distinct pathways. (1) Statewide Home Food Processor License (dating to 1980s): Requires a license (\$unknown fee), kitchen inspection by DACF Division of Quality Assurance and Regulations, and well/septic testing if not on public systems. Most non-TCS shelf-stable foods allowed; some acidified foods and low-sugar jams need University of Maine lab approval (~\$26-39/product). Sellers at farmers markets also need a Mobile Food Vendor license. (2) Local Food Sovereignty Ordinances: First adopted by Sedgwick in 2009; by 2025 over 80+ municipalities have adopted ordinances. Under §284, these municipal ordinances override state food law for direct producer-to-consumer transactions. The Food Sovereignty Act (PL 2017, c. 314) codified this at the state level. PL 2025, c. 309 (enacted in 2025) made significant amendments adding new definitions (consumer, food producer, food sovereignty, traditional foodways) and expanding the food producer definition to include those who acquire food from another source and process/prepare it in a kitchen. Maine’s Constitution Article I, Section 25 (Right to Food, adopted 2021) provides additional legal foundation. ‘Uncontrolled children’ are prohibited in the kitchen during production under the statewide license rules.

Allowed foods

Under the Food Sovereignty Act, in municipalities with local food sovereignty ordinances, almost any food produced and sold in a direct producer-to-consumer transaction is allowed, including vegetables, fruits, eggs, dairy, meat, poultry, fish, seafood, cider, juice, acidified foods, canned fruits/vegetables, honey, nuts, maple products, baked goods, sandwiches, and other meals. RESEARCH NOTES

Maine’s Food Sovereignty Act creates a complex patchwork depending on whether individual municipalities have adopted local ordinances. Cumberland County contains Portland (largest city in ME). County government URL appears to be the health dept (per batch input data formatting irregularity). No county-wide overlay found.

Home kitchen rules

HOME KITCHEN ALLOWED	Yes — Maine has two pathways: (1) Statewide Home Food Processor License: requires kitchen inspection by Maine DACF, well/septic testing if not on public systems, most non-TCS shelf-stable foods allowed; some acidified foods require University of Maine lab approval. (2) Local Food Sovereignty Ordinance (for participating municipalities): in towns with a food sovereignty ordinance, almost any food can be sold direct producer-to-consumer with minimal restrictions. York County has many municipalities; check individual town ordinances for food sovereignty participation.
SEPARATE DEDICATED KITCHEN	No
PET RESTRICTIONS	Maine statewide Home Food Processor License rules prohibit 'uncontrolled children' in the kitchen during production. Pet restrictions apply under GMP standards; pets may be considered a contamination risk during inspection.
WATER SUPPLY	If not on public water/sewer systems: well water and septic testing required for the statewide Home Food Processor License pathway.
HANDWASHING	Adequate handwashing facilities required; verified during kitchen inspection under the statewide license pathway.
FOOD STORAGE	Non-TCS shelf-stable foods under the statewide license. Acidified foods (salsas, pickles, certain dressings) require prior University of Maine School of Food and Agriculture approval (~\$26-39/product). Low-acid pressure-canned foods may not be sold.

MAX EMPLOYEES IN HOME	No explicit employee cap in Maine cottage food programs; home occupation zoning may restrict non-resident employees.

RESEARCH NOTES

Input JSON had malformed fields (county_seat was 'Freedom', notes was 'verified-large'). York County seat is Alfred (confirmed from general knowledge; York County is a coastal county in southern Maine). The input fields for county_govt_url, county_health_url, county_planning_url, and county_code_municode appear to have been shifted/corrupted in the source data — I used the yorkcountymaine.gov and yorkcounty.gov/planning values that appeared in shifted positions. Maine's dual pathway (statewide license vs. food sovereignty) makes York County complex as municipalities vary widely. Over 80 Maine municipalities have food sovereignty ordinances as of 2025. PL 2025 c. 309 made significant amendments to the Food Sovereignty Act in 2025.

Crosodo Index methodology: The Crosodo Index is our internal 1–N ranking of U.S. counties by how friendly the combined state + county rules are for home-based cottage food bakers. Score components (higher = better): home kitchen allowed (30/15/5), no dedicated kitchen required (25), pets allowed (15), no home occupation permit (15), on-site pickup allowed (10), no inspection (10), no local business license (5), high data confidence (5), plus state tier bonus (Freedom +20, Great +15, Good +10, Okay +5). Data drawn from county zoning codes, health department rules, and state cottage food statutes (primarily the county_cottage_food_zoning research set and state statutes CSV, last verified ~2026). Ranks are global across ~3,000 counties. Counties with sparse or missing data receive lower/default scores. This is a research and prioritization tool only — always verify current rules directly with your state department of agriculture/health and your county planning & health offices. The original U.S. Census population rank is retained in source data for reference but is no longer used for primary display or sorting in Crosodo materials.
