SUMMARY:						
The proposed	budget, a summary for all funds	s, and the budget ordinance is included	in your notebook, as well as the proposed CIP.			
An increase of 1.7 cents to the property tax rate is included in the proposed budget, which is needed as a pass-thru of the Pinecroft Sedgefield Fire District 1.72 tax rate increase. The Town will absorb the .02 cent difference.						
Water rates will remain unchanged, and sewer rates will decrease approximately 14%.						
Projects of approximately \$1.3 million are included in the 2020-21 General Fund fiscal year budget. These are all included on the CIP, as well as about \$2.6 million in sidewalk projects that are set up as capital project funds, so do not impact the operating budget. Water and sewer projects include approximately \$2 million for Eastside Wastewater Treatment Plant and Riverdale Pump Station improvements, as well as approximately \$1.7 million in Town water and sewer improvements.						
This budget calls for Fund balance to be used in amounts of approximately \$1.2 million in the General Fund and \$1.9 million in the Water & Sewer Fund to fund capital items.						
The proposed 2020-21 budget (total of all funds & excluding inter-fund transfers) shows a 31% increase from the 2019-20 amended budget. The General Fund budget increased 9%, in part due to \$275,000 of street resurfacing planned in 2020-21; the water & sewer budget increased 64% due to almost \$4 million in capital improvements for water and sewer.

## A RESOLUTION ADOPTING A CAPITAL IMPROVEMENT PROGRAM FOR THE TOWN OF JAMESTOWN FOR FISCAL YEARS 2020/2021 TO 2024/2025

WHEREAS, capital planning and budgeting is central to delivery of essential services, economic development, transportation, communication, and management of quality of life; and

WHEREAS, much of what is accomplished by a local government depends on a sound long-term investment in facilities, infrastructure, and equipment; and

WHEREAS, some capital projects and items require the issuance of the debt that results in annual operating debt service repayment, as well as additional annual operating costs; and

WHEREAS, these costs should be considered when determining which capital projects and items the Town of Jamestown will pursue;

**NOW, THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Jamestown that the Capital Improvement Program for the fiscal years 2020/2021 through 2024/2025 is hereby adopted;

**BE IT FURTHER RESOLVED,** that adoption of this Capital Improvement Program does not constitute approval of the projects listed therein. Each project will be evaluated individually and approval or disapproval given based on the merits of the project. The Town Council directs Town staff to use the adopted document as a guide for proceeding with the implementation of projects detail in fiscal years 2020/2021.
