## SECTION VI

## TAXES LEVIED

There is hereby levied the following rates of tax on each one hundred dollar (\$100.00) valuation of taxable property, as listed for taxes as of <u>January 1, 2013</u> for the purpose of raising the revenue from Current Year's Property Tax, as set forth in the foregoing estimates of Revenue, and in order to finance the foregoing appropriations:

General Fund (for the general incident to the proper government of the Town ) ¢.445

Total Rate per \$100.00 Valuation of Taxable Property €.445

Such rates of tax are based on an estimated total valuation of property for purposes of taxation of \$ 402,053,983 at an estimated rate of collections of 97.00 %.

The Town taxes will be payable under the same discount rate applicable to County taxes.

## SECTION VII

## APPROPRIATION TRANSFERS AUTHORIZED

The Budget Officer is hereby authorized to transfer appropriations as contained herein under the following conditions:

- a. He/she may transfer amounts between line item expenditures within a department without limitation and without a report being required. These changes should not result in increases in recurring obligations such as salaries.
- b. He/she may transfer amounts up to \$25,000 between departments, including contingency appropriations, within the same fund. He/she must make an official report on such transfers at the next regular meeting of the Governing Board.
- c. He/she may not transfer any amounts between funds, except as approved by the Governing Board in the Budget Ordinance as amended.

#### SECTION VIII

## AUTHORIZATION TO EXECUTE CONTRACTUAL DOCUMENTS

The Town Manager, Assistant Town Manager and Finance Officer are hereby authorized to execute contractual documents on behalf of the Town of Jamestown for the purchase of apparatus, supplies, materials, or equipment up to \$89,999.99 upon the condition that they are in compliance with the requirements of Article 8 of Chapter 143 of the North Carolina General Statutes. The Town Manager is further authorized to enter into general contracts and agreements on behalf of the Town of Jamestown up to \$50,000. The Town Manager, Assistant Town Manager, Parks Superintendent and Recreation Supervisor are authorized to enter into contracts and agreements for the rental or use of recreation facilities at Town parks.

## SECTION IX

## **DISTRIBUTION**

Copies of the Ordinance shall be furnished to the Finance Officer of the Town of Jamestown, to be kept for direction in the disbursement of funds.
