

Town to Consider Ordinance Updates and Rezoning Requests

The Town of Jamestown will be considering several items at the upcoming Planning Board and Council meetings in the coming months, including a small rezoning. The



rezoning was a result of the recently closed portion of the unopened right-of-way for Camelot Dr., which is located adjacent to the apartments being constructed near Jamestown Parkway. The closing of the right-of-way means that small portions of land will be assimilated into the properties which lie adjacent. The Town will simply apply current zoning to the newly created property.

In addition, the Town will be requesting direction from the Planning Board related to a number of items for potential updates to the Land Development Ordinance.

Included in those items are:

- 1) Whether or not to create ordinances as they relate to the keeping of chickens within the Town's jurisdiction.
- 2) Regulating the land use related to Tattoo Studios.
- 3) Regulating the land use related to winery/distillery/brewery operations.
- 4) Regulating the use of chain link fence within residentially zoned areas.
- 5) Regulating the land use related to the parking of commercial vehicles over one ton within residential neighborhoods.

The Planning Board will consider these requests at their February 13, 2017, meeting in the Council Chambers at 6:30pm. Using the direction given at that meeting, the Planning Department will craft ordinance updates for consideration by the Planning Board and Town Council at future meetings.

I have thoroughly enjoyed working for the Town of Jamestown. As many know, I was born and bred in Jamestown. I attended Jamestown schools. After graduating from Ragsdale High School, I headed out west to Colorado State University. I realized I had made a big mistake and I couldn't wait to get back to Jamestown. I never left Jamestown again.

Later, I worked for my father, Bow Stafford, in the family business of real estate, land development, property management and insurance. I have seen a lot of changes in Jamestown over the course of my life and the years spent working with the Town. Ragsdale, Sr. built Forestdale Plaza shopping center in the mid 1970's. This brought a grocery store, drug store and laundry mat downtown.

There have been many changes since those days. Now Jamestown is a place to stop and spend time shopping, eating, enjoying walks along the brick sidewalks and hanging out at Wrenn Miller Park. While the Town is still recognized as a bedroom community consisting of mainly residential uses, we truly have all the amenities our citizens require. There is little reason to leave the Town limits for one's daily needs. And why would you want to leave Jamestown. I have always said Jamestown is the best little Town in the USA!

So, while I am retiring, I am not leaving Jamestown. Again, why would I. This is my hometown. It has been a true pleasure and privilege to work for the Town of Jamestown. It has been an honor to serve our citizens. While I will not be at the Town Hall after April, I will see you around Town. There is no telling where I may pop up. I will miss working with the public and the Town staff. However, I must be honest, I will not miss taking the minutes.


Until then, I wish you much happiness and good health for all the years to come.

Public Services Notes

Loose Leaf Collection to End February 24

The Town of Jamestown's annual Leaf Collection Program ends on February 24th, 2017. We would like to thank the residents of Jamestown, as the program has run smoothly again this year. Due to some mechanical breakdowns of late, we have not been able to run the route as frequently as we would like to. We have already completed the route 16 times.

Water Line Improvement Projects

We are nearing completion of the Gannaway Street water line replacement project. The line had three breaks in recent years, so it was necessary to replace the line before adding additional services for the new construction underway on Gannaway Street. The project is slightly behind schedule due to a combination of bad weather and rock encountered in the excavation. The new line will hopefully be placed into service in February.

We are also replacing water line valves at the intersection of Perry Road and Ragsdale Road. Some of the aging valves were ineffective and would not allow us to operate the water line effectively in the event of an emergency. The project should be completed in early February.
