Yard Waste Collection Resumes Regular Standards on June 5

Relaxed rules from Ice Storm Debris collections Ends

The Public Services Department is concluding debris pickup from the March 6-7, 2014 Ice Storm. The storm qualified as a Federal Disaster by FEMA. We will stop debris pickup from the ice storm on Thursday, June 5, 2014. Thus, when we resume yard waste pickup on Wednesday, June 11, 2014, we will be enforcing our normal rules. We had to establish the end of the ice storm debris clean up - it is the deadline after which we will not receive any reimbursement from FEMA.

Shortly after the ice storm we relaxed our rules about yard waste pickup. This was done to speed up the recovery and provide the citizens with an easier method to dispose of the material. The Town used its heavy equipment, rental equipment, staff from all departments and positions, and a subcontractor to collect over 800 tons of debris from the event. We collect about 450 tons in a normal year. The downside of this work is we had to delay certain functions which we are now beginning to catch up on. This is why we need to return to our normal policies. Some of the key rules that need to be followed include:

- Material must be cut to 6 feet in length or less.
- Material should not weigh more than 50 pounds.
- We do not pick up yard waste that has been cut, mowed, or otherwise generated by the work of contractors. Contractors hired to cut trees and shrubs, trim trees and shrubs, mow yards, etc. are responsible for hauling off the material they generate. The Town will not pick up this material. We will inform the property owner/resident of the site when we become aware of this situation. If necessary, we will follow up with enforcement actions as allowed by Town policies.
- We do not pick up loose leaves EXCEPT during the loose leaf collection season. These dates are posted each year as we approach the season, but it is generally from the end of October through mid-February. Our loose leaf collection program is very easy to participate in - we collect loose leaves continuously during the three month plus season. We cannot extend the season as staff is committed to other duties after the season and our equipment is being serviced. Please bag any leaves you want picked up until loose leaf season begins.
- We have returned to the usual yard waste collection route. We are not able to make a complete cycle around Town each week due to the amount of debris being placed at the curb. We should soon be able to reach every neighborhood each week as the amount of storm debris at the curb decreases. We sincerely apologize that we cannot run the entire route each week.

We appreciate the work our citizens have performed in cutting, dragging, and stacking their mate-

rial at the road. We also appreciate your patience as we have worked through this disaster. We look forward to several months of moderate weather for everyone to enjoy and every tree to recover.





Town Staff is pleased to present the Draft Budget for Fiscal Year 2014/15, beginning July 1, 2014 and ending June 30, 2015 for your consideration. The Draft Budget has been prepared in accordance with the North Carolina Local Government Fiscal Control Act as required by NC General Statute Chapter 159-11. The budget document represents balanced revenues and expenditures. Achieving a balanced budget continues to remain a challenge as infrastructure needs increase and available sources of funding decrease or become scarce.

The Draft Budget:

- Includes a 1¢ tax increase
- Includes a 3% water and sewer rate fee increase
- Maintains current levels of service to the citizens
- Maintains current levels of benefits for employees
- Maintains current staffing levels for all departments
- Includes COLA and merit raise increases for employees
- Contains funding to purchase a new garbage truck via installment financing
- Contains funding for water & sewer extensions to Grandover Shopping Center area
- Contains funding and financing for a new Public Services Maintenance facility
- Contains funding and financing for renovation of the golf course clubhouse and a new community center
 - The proposed FY 2014/15 total revenues and other financing sources and expenditures and other financing uses of all funds represent a 5.90 % increase compared to the FY 2013/14 budget.

All revenues which comprise the General Fund have been forecasted in a conservative manner. Staff has reviewed the projections for state-collected revenues published every year by the North Carolina League of Municipalities, varied data collected by the Piedmont Triad Regional Council, current economic trends for Central North Carolina, current nationwide economic trends and historical financial data from the Town.

The 2014/15 budget may be summarized as the year of vital improvements to aging facilities and an expansion of Jamestown utilities. Now through next budget year we can move forward with a growing momentum to construct new infrastructure to serve Jamestown citizens well into the latter part of this century.

Meetings, as necessary, are held on the first Monday of the month at 6:30pm at Town Hall.

TREE REPLACEMENT SPONSORSHIP PROGRAM

Do you want to help replace trees in Jamestown's beautiful parks while honoring a loved one?

The ice storm of March 6th and 7th of this year was very damaging to trees at Jamestown and Wrenn Miller Parks. Town staff intends to replace trees removed in most areas of Wrenn Miller Park and in the Jamestown Park recreation and entrance areas.

What you can do...

By purchasing a commemorative tree you will help restore the natural beauty of our parks while honoring a loved one, family, civic club, or business. Town staff will work with you in selecting the tree replacement location at either park. The species of trees planted will be determined by planting location, tree species compatibility, and the Town's master park plan. Commemorative plaques will be placed on or near the plantings to preserve plant health. Costs range from \$200 to \$300 each depending on species and include a plaque.

When will the tree replacement process begin?

Depending on the hardiness of the tree species, replacement may begin as early as August, however, most trees will be planted in September and October of this year.

Don't wait, order now ...

There are very desirable locations available in Wrenn Miller Park along the winding sidewalks and near the amphitheater and shelter. A few trees will be replaced along the trail at the Jamestown Park main entrance.
