TURF EQUIPMENT MECHANIC

GENERAL STATEMENT OF DUTIES

This position is responsible for the on-going maintenance and up-keep of all equipment used in the daily operation of the golf course. Assure equipment is repaired in a timely and efficient manner, working properly, and receives regularly scheduled maintenance.

ORGANIZATIONAL INFORMATION

Salary grade: 13. Exercises no supervision. Generally scheduled between the hours of 6AM-3PM, Monday-Friday. Reports directly to Golf Maintenance Superintendent.

DISTINGUISHING FEATURES OF THE CLASS

Work is done in a maintenance shop on the golf course property, employee works independently, maintains maintenance schedule and inventory.

ILLUSTRATIVE EXAMPLES OF WORK

- Repairs broken mowing & related golf course maintenance equipment; greases, changes oil, & cleans equipment as preventative maintenance.
- Diagnoses & repairs hydraulic systems malfunctions; replaces clutches in dump trucks; welds & fabricates metal parts; sharpens blades on mowers & lapping reels.
- Orders supplies for shop & parts needed for repairs & maintains service records of equipment.
- Maintains & organizes materials safety data sheets (MSDS).
- May perform work in other laboring classifications as needed.
- Follows safety procedures, rules, & regulations.
- Uses hand tools, hand power equipment, chain saws, blowers & other tools to perform various types of manual labor.
- Any other duties as assigned.

KNOWLEDGE, SKILLS AND ABILITIES

- General knowledge of the operation and maintenance requirements of the equipment used in carrying out assignments.
- Thorough knowledge of small engine repair.
- Ability to diagnose mechanical problems.
- Skilled in use of mechanic tools.
- Good judgement and reasoning skills.
- Ability to communicate effectively.
- Ability to establish and maintain collaborate working relationships.
- General knowledge of the policies and procedures to be followed in carrying out assignments.

DESCRIPTION OF PHYSICAL EXERTION AND WORKING CONDITIONS

Heavy Work- Exerting up to 100 pounds of force occasionally, and/or up to 50 pounds of force frequently, and/or up to 20 pounds of force constantly to move objects. Employee is required to have visual acuity to operate motor vehicles or heavy equipment,

Employee is subject to outside environmental conditions: No effective protection from weather. Employee is subject to both environmental conditions: Activities occur inside and outside. Employee is subject to extreme cold: Temperatures typically below 32 degrees for periods of more than one hour. Employee is subject to extreme heat: Temperatures above 100 degrees for periods of more than one hour.

EDUCATION AND EXPERIENCE

Minimum requirements: Graduation from a high school or GED program and three (3) years of experience as a mechanic, preferably with experience in repairing small engines, turf equipment and mowers. Preferred: Post high-school coursework in small engine mechanics, diesel mechanics, or similar trade and one (1) or more years of experience as a mechanic at a public or private golf maintenance facility. Or an equivalent combination of education and experience.

SPECIAL REQUIREMENTS

North Carolina Driver License- Class "C" is required.
