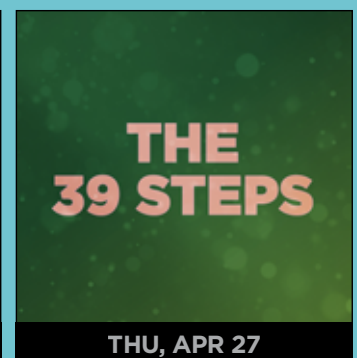
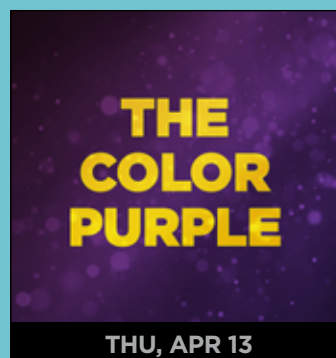
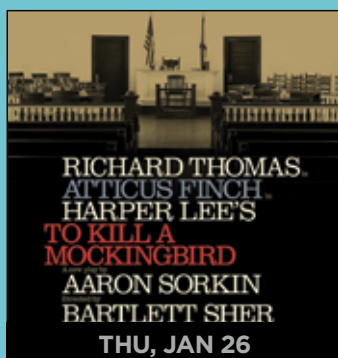
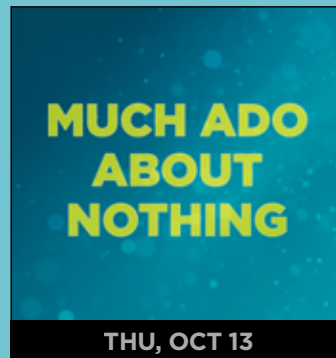
INSPIRATIONAL LIVE PERFORMANCES
