SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures:

By inhalation:

SECTION 5: FIREFIGHTING MEASURES

5.1 Extinguishing media:

Suitable extinguishing media:

If possible use polyvalent powder fire extinguishers (ABC powder), alternatively use foam or carbon dioxide extinguishers (CO).
