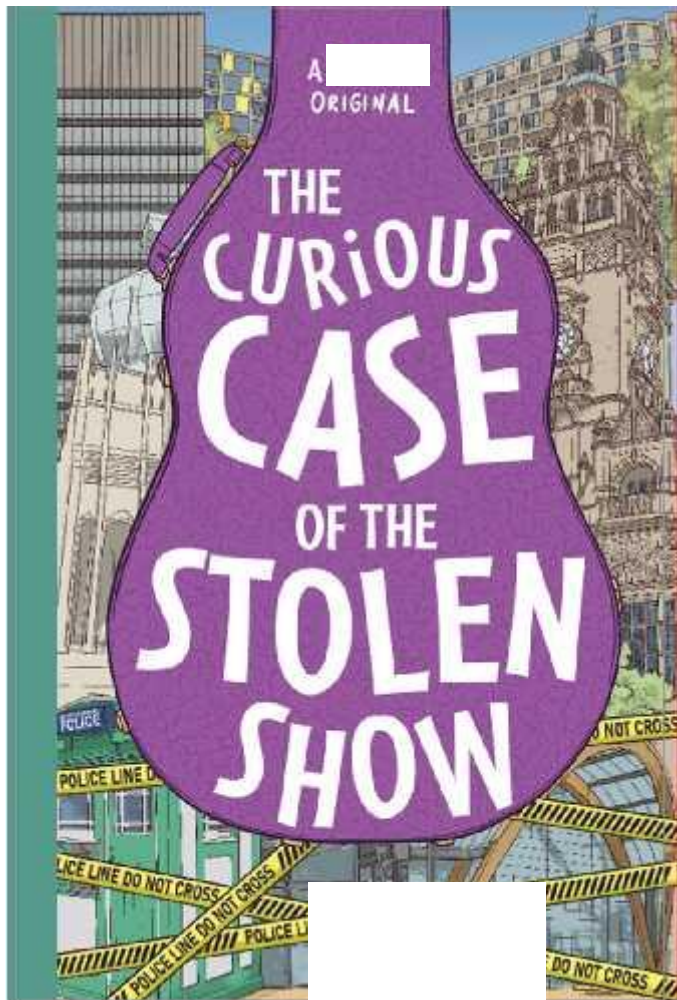

Can you make any predictions about the book?

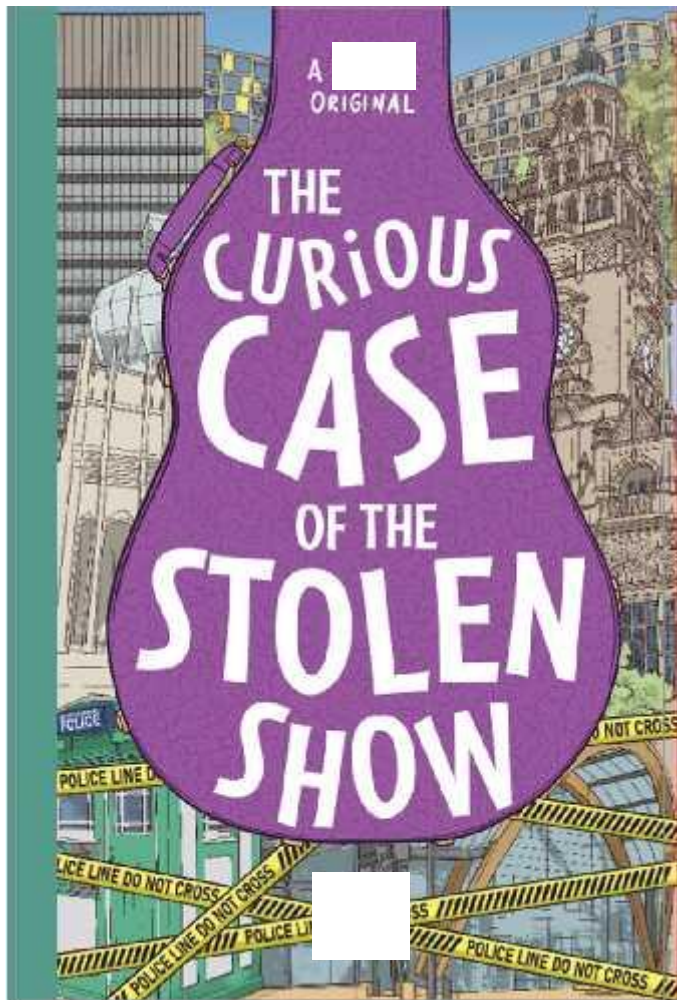
Back Cover

During and After Reading Each Chapter



These slides are intended to be displayed while each respective chapter is being read by a group or class.

They could also be displayed before or after each chapter is read and be used with either a group or an individual reader.

Each chapter has three questions plus a 'Detective Challenge'. These are designed to:

- increase specific focus while reading and develop skills in comprehension, inference and retrieval;
- prompt discussion and analysis of the content afterwards.

Answers are provided to the main three questions, although these are suggested answers only and a range of answers or discussion points may be relevant.
