
# Citizenship: Responsibilities

Citizens belong to a **community**, a place where people live, work, and play. Being a citizen brings freedoms and protections from the community to which you belong, but along with those freedoms and protections comes responsibilities. **Responsibilities** are things you are expected to do. We have responsibilities at home, at school, and in the community. As citizens, we are <u>expected</u> to follow rules and laws to help keep people safe and maintain order.

<u>Responsibilities of Citizens</u>

There are many responsibilities you may have at school. Can you think of an example of responsibilities you have in your classroom or in the cafeteria? In the classroom, your teacher may ask for your vote in making decisions such as <u>developing</u> classroom rules, choosing a class reward, or deciding on an activity. This act of voting is an example of a responsibility. When you complete assignments, you are expected to be honest by doing your own work. Honesty can also be seen when there is a conflict and your teacher asks for you to explain what happened. Being honest over a period of time shows the **trustworthiness** of a person, the ability for people to believe the things you say and do. Students are expected to control themselves and do the right thing, also known as **self-discipline**.

At home and in the community, you have many responsibilities as well. Your parents may have you take out the trash or keep your room clean. You are expected to respect the property of your siblings by treating it the way you would treat your own things. In the community, you are charged with this same responsibility of respecting and protecting the rights and property of others. For example, citizens are not to enter the homes of others without permission or take things from businesses without paying for them. Citizens have the responsibility to take care of themselves when possible. For example, when you are old enough to have a job to earn money and are physically able to do so, it is your responsibility to provide for yourself. This responsibility is called **self-reliance**. While people should always <u>aim</u> to help others, citizens should not solely rely on others to do things they themselves are capable of.


