The Stewards, having received a report and video evidence from the ELMS Race Director, having summoned and heard the Competitor and having considered the following matter, determine that a breach of the regulations has been committed by the competitor named below and impose the penalty referred to.

Facts

After the chequered finish flag, during the lap to reach the Parc Fermé, car n. 60 was pushed

by car n. 83.

Offence

Breach of Art. 15.1.1 of 2022 ELMS Sporting Regulations and Art. 2.5 of FIA ISC

Decision

1) Due to the breach referenced about the Competitor is Disqualified from the Race results (Art. 12.4.1 m of FIA ISC)

2)The Stewards order that the Classification be amended so that the other competitors be

moved up in the Classification in accordance with Art. 12.19 of the FIA ISC.

3) Any awards or prizes should be returned to the organiser and issued to the competitors

moved up in the Classification in accordance with Art. 12.18 of FIA ISC.

Reason

The ELMS Sporting Regulations have not been respected by the Competitor named below because the car n. 60 was pushed by car n. 83 after the chequered flag which has been confirmed by the team manager of car n. 60 during the hearing and seen by the video evidence. The Stewards consider that this is a breach of article 15.1.1 of ELMS Sporting Regulations. In the opinion of the Stewards, the Parc Fermé rules have not been respected because at the end of a competition the area between the finish line and the Parc Fermé entrance shall be placed under the Parc Fermé regulations; that means that no car is allowed to receive any assistance from any other competitor. This is a clear breach of art 2.5.5 of FIA ISC. Therefore the Stewards decide to disqualify the competitor car 60 from the Race results. This decision has been taken in accordance with the Art. 11.9.3 i) and art. 12.4.4 of FIA ISC

The Competitors are reminded that they have the right to appeal certain decisions of the Stewards, Art.15 of the FIA International Sporting Code, within the applicable time limits.
