## TRIUNFO WATER & SANITATION DISTRICT FISCAL YEAR 2020-2021 AND 2021-2022 BUDGET DEVELOPMENT SCHEDULE

#### **Summary**

The Triunfo Water & Sanitation District (Triunfo) Fiscal Years 2020-2021 (FY2021) and 2021-2022 (FY2022) cover the period from July 1, 2020 through June 30, 2022. It is desirable that your Board adopt an annual budget prior to the start of FY2021. Additionally, your Board has given direction to prepare a two-year budget, opposed to the past practice of developing of a new annual budget to be approved by your Board during the Spring preceding each fiscal year. The attached budget development schedule identifies significant milestones in that process.

#### **Background**

On October 8, 2019, your Board gave direction to prepare a two-year budget during the next budget development process. The budget includes information from a number of sources, including public agencies such as the Calleguas Municipal Water District (wholesale water supply costs), the Las Virgenes – Triunfo Joint Powers Authority (wastewater treatment costs, recycled water costs), and the Ventura Regional Sanitation District (management, staffing, and operations). The budget also incorporates the District's Capital Improvement Projects (CIP) program.

In addition to the external inputs, the Triunfo Board may also adopt new or enhanced programs that require funding through the budget process. As a result, the budget schedule is subject to change.

#### Recommendation

It is recommended the Board receive the budget development schedule and direct staff as appropriate.
