AMENDMENT OF TRIUNFO WATER & SANITATION DISTRICT'S CONFLICT OF INTEREST CODE

SUMMARY

The Triunfo Water & Sanitation District (TWSD) Board of Directors adopted, as its Conflict of Interest Code (Code), the terms of California Code of Regulations, Title 2, Section 18730. The District is required to review its Conflict of Interest Code biennially in even-numbered years and submit any changes to the Code reviewing body. In addition, any amendments to the Code must be submitted to the same reviewing body for approval.

The Ventura County Board of Supervisors is the code reviewing body for the District and they are required to review and approve TWSD's code for any changes. Due to administrative changes within TWSD as part of its transition, it is necessary to amend the code to reflect newly added positions. In order to assist the County in updating its records, the County Clerk of the Board recommends the TWSD Board review and approve the necessary changes and direct the District Clerk to submit the Conflict of Interest Code Amendment Form with updated documents to the County.

Attached for the Board's consideration is Resolution No. T2021-001 amending the District's 2018 Conflict of Interest Code (reviewed and renewed in August 2020). The changes included are the addition of a Chief Financial Officer, Administrative Program Manager, and Engineering Program Manager. The amended Code includes a revised Exhibit A to list the new positions.

All other positions that were listed in 2018 continue to be the only ones managing TWSD's public investments, as defined in 2 California Code of Regulations section 18701 and Government Code section 87200.

All positions are listed as Category 1, requiring full disclosure of all sources of income, gifts loans, and travel payments; all interests in real property; and all investments and business positions in business entities.

- C. Direct District staff, upon approval of Ventura County Board of Supervisors, to promulgate the 2021 Conflict of Interest Code and ensure that Form 700 Statements of Economic Interests are filed appropriately by the designated staff persons.

The terms of the California Code of Regulations, Title 2, Section 18730, and any amendments to it, duly adopted by the Fair Political Practices Commission, are hereby incorporated by reference as the Amended Conflict of Interest Code for this agency and, along with the attached Exhibit A and Exhibit B in which officials and employees are designated and disclosure categories are set forth, constitute the Conflict of Interest Code of the Triunfo Water & Sanitation District; and
- 2. Pursuant to Section 4 of the Standard Code, designated employees shall file statements of economic interests with the agency; and
- 3. Upon receipt of the statements of the members of the Board of Directors, General District Manager, Director of Finance & Administration, Chief Financial Officer, Administrative Program Manager, Engineering Program Manager, and General Counsel, the agency shall make and retain a copy and forward the original of these statements to the County Clerk of Ventura County.
- 4. Every report and statement filed pursuant to the Conflict of Interest Code is a public record open for public inspection and reproduction subject to Government Code Section 81008.
