T-MOBILE REQUEST FOR EQUIPMENT MODIFICATIONS AT THE SAVOY SITE

The Triunfo Sanitation District (TSD) Board entered into a site lease agreement (TSD No. T99-05) with PacBell Wireless/T-Mobile West, LLC (T-Mobile), on April 26, 1999, for placement of a cell tower facility at the Savoy water reservoir site. The terms of the agreement included a provision that allows T-Mobile to make minor modifications to its equipment as part of ongoing routine operations and maintenance. T-Mobile has requested to replace and improve the antennas and certain components of the transmitting equipment to expand broadband connectivity and system capacity. These changes involve no change of the physical dimensions of the antennas array pattern or equipment footprint and will not further impair the District's ability to operate its facilities at this site. T-Mobile requests a Letter of Authorization from TWSD (as the landlord) to present with their upgrade CUP request to the County of Ventura Planning Department as part of the permitting process for these modifications. Staff is recommending that the Board approve the General Manager to sign the Letter of Authorization and approve the requested modifications.
