Unclaimed Checks Less Than \$15

Summary

On April 25, 2022, the Triunfo Water & Sanitation District Board approved the TWSD Unclaimed Property Policy. Government Code Sections 50050 through 50057 provide the District with the authority to take possession of checks that are less than fifteen dollars (\$15) and have remained unclaimed for over a year without public notice.

Discussion

To minimize the number of unclaimed checks and the continued efforts to contact customers regarding closed account refunds, staff is requesting the Board approved Resolution No. TWSD 2022-013 to transfer the unclaimed checks less than fifteen (\$15) back to the funding source that it was originally drawn or deposited.

In addition, staff is requesting the Board approve transferring \$396.92 that currently remains unclaimed dating back to June 2015 and prior. These funds spans 20 years moving forward, and the District no longer has documentation supporting these unclaimed funds. If we receive a request to be reimbursed, with proper documentation, staff will honor the request.

Fiscal Impact

The total amount of unclaimed checks is \$451.25 (\$54.33 for less than fifteen (\$15) and \$396.92 for unclaimed funds greater than \$15, dating back to June 2015 and prior).

Recommendation:

It is recommended the Board:

- A. Approve Resolution No. TWSD 2022-013, to transfer the attached list of checks that are fifteen (\$15) or less back to the funds where it was originally drawn or deposited; and
- B. Approve transferring \$396.92 unclaimed funds dating back to June 2015 and prior to the District's miscellaneous revenues.
