DISCUSSION OF WILDFIRE DAMAGE TO FACILITIES AND PROVIDING RELIEF TO DISTRICT RESIDENTS THROUGH ADOPTION OF RESOLUTION NO. TSD 2018-007


Recommendation

On November 8, 2018, a major wildfire known as the "Woolsey Fire" broke out in Ventura County and quickly spread into the Triunfo Sanitation District (TSD) service area. This prompted local officials to require mandatory evacuations and there were numerous homes either threatened or destroyed. Staff has been approached by a number of concerned residents regarding TSD provided services. Specifically, inquiries as to the cost of water used for fire related activities and wastewater fees for homes either identified as uninhabitable or destroyed. As a result, your Board requested staff to schedule a Special Board Meeting for tonight to discuss the impact from the fires and provide staff with direction on the best course of action to help fire impacted residents. Staff has drafted a proposed Resolution that is based on a recently adopted resolution by Las Virgenes Municipal Water District (LVMWD) as an emergency response to the fires. Staff recommends the TSD Board discuss the wildfire impacts and the options available, and provide staff with direction, including, consideration of adopting TSD Resolution No. TSD 2018-007. Staff recommendations address the immediate concerns of the residents, however, as new issues are identified, the TSD Board may elect to take further related action.

- 1. Waive water and wastewater charges for the billing period during which a home was destroyed or rendered uninhabitable due to the fire.
- 2. Reduce bills for water consumed to reflect the previous month billing, on a caseby-case basis, for customers whose homes were not rendered uninhabitable, but who used an extraordinary amount of water to protect their properties.
