4. Woolsey Fire Impact on Triunfo Sanitation District's Facilities

General Manager Mark Norris and Chair Janna Orkney asked that Water/Wastewater Staff Superintendent Richard Jones introduce Oak Park Staff to the Board that initially responded to the Woolsey Fire. Mr. Jones introduced Water/Wastewater Workers Timothy Bouyett, Giovanni Malagon, and Johnathan Lavergne. Also present were Water/Wastewater Operations Supervisor Justin Robbins and Director of Operations Matt Baumgardner.

After being acknowledged, Water/Wastewater Workers left the meeting to reunite with their families.

Mr. Jones provided a timeline of all activity that staff initiated once the fire started. The proactive measures taken by staff minimized the fire's impact to TSD facilities and allowed for sufficient water supply to first responders. Damage was limited to barrier posts by the Oak Canyon Reservoir, straw waddles used for erosion control, and some communication wiring. All damage is in the process of being corrected.

Chair Orkney and the Board expressed its appreciation for all of staff's efforts and for the report given.

Director Tjulander left at 6:11 p.m. and did not return.
