INVESTMENT REPORT – NOVEMBER 2019

Summary

The attached report shows cash and investment holdings of the District on November 30, 2019. The District's policy is that the report be provided within 30 days of the close of the month. The balance of the portfolio, at cost, was \$12,033,512 on November 30, a \$98,016 increase compared to the prior month. This net increase is a result of lower cash disbursements in November, particularly due to the delay of JPA monthly payment. Interest earnings of \$20,563 for the month were accrued and the fiscal year to date at \$111,209.

The Treasurer manages all District investments. All District investment holdings are in compliance with the investment policy approved by the Board of Directors in January 2018. The investments of the District provide sufficient cash flow liquidity to meet the next six month's estimated expenses.

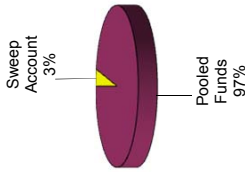
