BRIDGEGATE DEBRIS BASIN EASEMENT TRANSFER FOR HIDDEN VALLEY MAINTENANCE CORPORATION AND VENTURA COUNTY WATERSHED PROTECTION DISTRICT

Summary

In 2013, the Triunfo Sanitation District (TSD) was approached by representatives from Ventura County Watershed Protection District (VCWPD), Hidden Valley Maintenance Corporation (HVMC), and HVR Associates, LP (HVR) regarding the District's easement at the Bridgegate Debris Basin. At issue, the District's blanket easement rights for a sewer line traversing through HVMC parcels and VCWPD's debris basin. Specifically, VCWPD's desire to limit the easement to a more defined boundary supporting the current alignment of TSD's pipeline. As this easement dated back to the installation of the sewer line but was causing interference with development of the site, staff and District Legal Counsel worked to address VCWPD's request. Following a series of high-level meetings with the County and affected parties, several deed transfer and easement modification documents were generated for further review and execution. Unfortunately, due to a number of outside influences, the final set of transfer documents was never completed.

Recently, HVR approached District staff with a request to complete the easement transfer process and replace the blanket easement with a 15' wide easement along the sewer centerline and grant new easements for ingress and egress for the District. HVR provided draft documents for staff and District Legal Counsel to review and the documents meet the requirements by the District for the transfer to proceed. Staff recommends the Board approve the modified easement for the District's sewer system through the Westlake area and direct staff to complete the process and authorize the GM sign the deed agreements.

Fiscal Impact

There is no fiscal impact associated with the easement transfer as the District will retain its easement rights for the purposes of maintaining and operating the sewer line through the HVMC parcels and VCWPD's debris basin.

Recommendation

It is recommended the Board approve the requested easement change for the sewer line traversing through the Bridgegate Debris Basin and adjacent private-party parcels in Westlake and authorize the General Manager to sign the easement transfer documents.
