**INVESTMENT REPORT – AUGUST 2022**

**Summary**

The attached report shows cash and investment holdings of the District on August 31, 2022. The District's policy is that the report be provided within 30 days of the close of the month. The balance of the portfolio, at cost, was \$23,896,600 on August 31, a \$23,316 decrease compared to the prior month. This net decrease is mainly due to funding operations. Interest earnings of \$24,822 for the month were accrued and the fiscal year to date at \$45,963.

The Treasurer manages all District investments. All District investment holdings are in compliance with the investment policy approved by the Board of Directors in January 2022. The investments of the District provide sufficient cash flow liquidity to meet the next six month's estimated expenses.

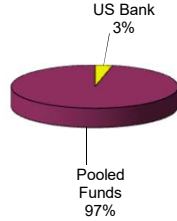
