TO CALIFORNIA STATE SOCIAL SECURITY AGREEMENT



Pursuant to authority vested in me for this purpose by the Governor of the State of California under date of May 5, 2016,

- (a) A majority vote by secret ballot was held on March 9, 2021 on the question of whether services of employees of Triunfo Water & Sanitation District in positions covered by Triunfo Water & Sanitation District (TWSD) 401a Plan should be excluded from or included under the agreement entered into on March 9, 1951 by the State of California, and the Commissioner of Social Security pursuant to Section 218 of the Social Security Act.
- (b) An opportunity to vote in such majority vote and was limited to eligible employees (as defined in section 218(d) of such Act) of such system;
- (c) Not less than ninety days' notice of such majority vote was given to all such employees;
- (d) Such referendum was conducted under the supervision of the California Public Employees' Retirement System duly designated by the undersigned to conduct such referendum; and
- (e) A majority of eligible employees voted in favor of including services of employees of Triunfo Water & Sanitation District in positions covered by Triunfo Water & Sanitation District (TWSD) 401a Plan under the agreement entered into on March 9, 1951 by the State of California, and the Commissioner of Social Security pursuant to Section 218 of the Social Security Act.

For the purposes of this certification, members of the Retirement System include individuals who are deemed members of the System under Section 218(d)(6)(E) of the Act.

No majority vote has previously been held in this political subdivision on the question of whether services in positions covered by the California Public Employees' Retirement System should be excluded or included under the agreement entered on March 9, 1951 by the State of California and the Commissioner of Social Security pursuant to Section 218 of the Social Security Act.
