### **CALL TO ORDER**

The regular meeting of the Library Board of Trustees of the National City Public Library was called to order by President Gogue at 5:30 p.m. on April 7, 2021.

This grant will allow the Library to replace the equipment and infrastructure currently in place to accommodate and support the increased bandwidth.

## **REVIEW OF NEW/UNFINISHED BUSINESS**

6. **Assistant City Manager Tony Winney – Update on Library and Community Services Director Recruitment.** With Director Duong's retirement, the City is taking a closer look at the organization and services it provides to the community. Along with the approval to consolidate the Library and Community Services, the City Council also approved in February the consolidation of Finance and HR. This is a broader and long term vision designed to garner the synergy, leverage assets, and more effectively serve the public in culture and arts. The City does not envision a negative impact on the two departments. The move will increase the caliber of programs with cost savings realized by the consolidation. The City retains the service of Bob Murray & Associates for a nationwide recruitment of the Director of Library and Community Services position. The position was posted on March 1 at twelve different government recruitment websites and will close April 25. The recruiter will meet with the City to review the pool of applicants. We plan on holding two interview panels where we'll invite the Chair of the Library and the Chair of Parks & Recreation to be part of the screening process.

The Board raised several concerns: how the incumbent will manage multiple responsibilities; whether there will be conflicts with two boards run by one common person. Trustee Godshalk inquired about how much savings the City anticipates realizing, how many other positions the City needs to hire to support this merger that will have the new Director oversee library, community services, and nutrition center; whether he/she will be responsible for everything the City Librarian is currently doing while being in charge of recreation and nutrition at the same time. Trustee Godshalk concluded that the ideal candidate - preferably bilingual - expected to do what Minh is doing right now, should be a librarian.

ACM Winney indicated he can't guarantee the new person is a librarian but assured the Board that the City is committed to ensure that the new Director will be "as responsive as Minh" and asked for the Board's support and leap of faith in considering this combined position, which is commonly done and works well in other cities.

President Gogue accepted ACM Winney's invitation to participate as panelist in the interview process. The Board also designated Trustee Godshalk as the Alternate panelist in the event President Gogue is unavailable.

7. **Review of Library Policies of Circulation Fines and Fees –** Trustee Godshalk enquired about "blocking" of library cards due to high fines, which creates a non-lending situation.

Director Duong explained that there is no privilege suspension until the card holder accrues over \$19 in fines; and that fines are not about money or penalty but about making borrowers accountable and responsible for returning the materials to allow other patrons to borrow them as well. Secretary Bang proposed a no-fines structure. After further clarification that a patron can always take a fine contest to the board if there is a disagreement, Trustee Godshalk made the motion to continue with the current fee structure in place and with library staff having the flexibility to address extenuating circumstances with lenience. 8. **Review of Children's Programming Policy –** Secretary Bang expressed that children's programming should include the diversity that takes into account the following considerations: Underserved, Race and culture, media, gender identity/gender expression, wealth and poverty, empathy and values, trauma and mental health. Trustee Moon expressed desire for National Library to be a leader in diverse programming. Trustees Godshalk and Juarez suggested further discussion on the matter.

## CITY LIBRARIAN AND PRINCIPAL LIBRARIAN'S REPORTS

- Local History Room Librarian Beatriz Esparragoza gave an update on the Digitization Project (PowerPoint attached). Director Duong explained that the digitization will provide remote access to the History Room collection.
  - The Library was also able to acquire additional issues of the Star News from Jan 2007 through December 2020 in PDF format, courtesy of the Star News publisher, thus expanding our collection to include recent and latest issues.
- Principal Librarian Defazio's updates:
  - National City 16-Week of STEAM program The Library has awarded more than 500 LED Meteor kits to registrants for the NC 16 Weeks of STEAM. Defazio acknowledged the Friends of the Library for their funding of supplies.
  - UCSD Sally Ride Partnership and Science STEAM programs UCSD Extension Sally Ride has shared five STEAM programs with National City Library, and we have 99 registrants for the five programs. Defazio acknowledged UCSD Extension for their donation of programs.

## **OTHER REPORTS** – Friends of the Library – Margaret Godshalk

- The National City Friends of the Library will convene on April 21 at the National City Library.

### **PUBLIC COMMENTS AND COMMUNICATION** –No comments.

Principal Defazio informed the Board that beginning next month, comments can be submitted live, as well as by email.

### **BOARD TRUSTEE COMMENTS/COMMUNICATION**

Trustee Moon enquired about the broadband upgrade, if it is secure and free, and what will happen to the old equipment. Ron Williams, City MIS Manager, explained that there is no cost to patrons to access our public network, however no public network is

- a secure and safe environment; old equipment goes to surplus. Director Duong explained that the upgrade will bring the broadband connectivity to 10 Gbps, serve more users, and expand access to Wi-Fi even in the library parking lot.
- ❖ Trustee Moon asked when the Library would reopen. Director Duong explained that effective today, we are in the Orange Tier of the Pandemic rating and we should hear soon on reopening. Trustee Moon asked about requiring vaccinations to enter Library. Director Duong stated that the City cannot mandate the public to get vaccinated before entering the library premises but it will put in place safety protocols as recommended by the County Health.
- Trustee Juarez thanked everyone for efforts to vaccinate and to staff for presentations and efforts.
