#### Public Comment

2. Drop-off a written statement at 1901 S Alamo, San Antonio TX 78204 by 4pm the day before the

meeting. The written statement can be up to 300 words. Please include your full name, home or work address, item # and / or address of the request. These will be read at the time the item is heard.

3. Leave a voice message of a maximum two minutes by dialing 210-206-DBSB (3272) by 4pm the day before the meeting. Your message will be played during the meeting. Please include your full name, home or work address, item # and / or address of the request.

4. Sign up to give your comments live during the meeting by leaving your name, telephone number, item # on which you would like to speak on at 210-206-DBSB (3272) by 4pm the day before the meeting. City staff will call you when your item is up for discussion but cannot guarantee a specific time. Once you join the call, you will be given two minutes to provide your comments; however, an owner or owner's representative will have unlimited time.
